Mayor's Message



Neighbourhood Plan – We Want Your Views!

The Neighbourhood Plan for Yateley, Darby Green and Frogmore is nearly finished! This is the Plan that will guide future planning decisions, sets out our expectations around design and reduce our environmental impact on climate change. A draft version of the Plan was approved by the Town Council at their meeting on 15th March 2021, and the first two bits of official assessment have been done by Hart District Council.

The next stage is to ask local residents for their views, because it is important that the plan genuinely reflects the aspirations of the community. We started this public consultation on 10th May and it is running for just over 7 weeks until 2nd July. The idea is that it gives the local community the opportunity to review the Plan, and pass any comments on to the Steering Group for their consideration. Residents will also get the chance to vote on the Neighbourhood Plan in a referendum when it has been through all the formal approval stages, but this is the last chance to make any significant changes.

Of course, we have already conducted a couple of surveys while putting together this Plan, so we expect that the plan should already be a fair reflection of local people's views. There are 15 policies in this Plan, which are described in overview below – the full document is available on our website.

Please take a few minutes to read the Plan and give us your feedback – it will help to ensure the best possible future for the development of our attractive and vibrant town.

The Neighbourhood Plan is a legal planning document governing land use in the parish of Yateley, which also covers the villages of Darby Green and Frogmore. It supplements Hart District's Local Plan, and enables residents in our community the opportunity to influence and control future planning decisions concerning our parish.

There are 15 policies in the document, which cover:

1. **Sustainable Development** – this requires any new development within the settlement boundaries to support environmental requirements, facilitate active travel, avoid areas of flooding, protect heritage assets, improve biodiversity and deliver affordable housing. Most of this is reinforcing policies already in place in the Hart District Local Plan.
2. **Climate Change** – the policy here goes further than the Local Plan in stipulating that all new development must demonstrate best practice in energy efficiency, and includes requirements to meet targets on carbon neutrality, make efficient use of water and provide electric charging points.
3. **Protecting Biodiversity** – this policy requires all new development to be done in such a way as to protect natural habitats, trees and hedgerows.
4. **Design Principles** – this policy covers a list of general design principles for the community, and particularly references a set of design principles published by the Urban Design Group in 2020 entitled "Building for a Healthy Life".

5. **Yateley Village Design Framework** – there was an extensive piece of work done by the local Councils and The Yateley Society regarding the design of the village centre, which was published in June 2009 and led to some of the improvements seen around Church End Green in Yateley. We believe the research and the recommendations contained in that document are still valid, so this policy incorporates those design principles for the Village centre area into the Neighbourhood Plan.

6. **Conservation Areas** – this policy stresses the importance to the community of the Darby Green, Cricket Hill and Yateley Green Conservation Areas.

7. **Views** – this policy identifies a small number of views within the parish additional to those already covered by other protection schemes and that are worthy of preservation.

8. **Green Infrastructure** – under this heading, we set out requirements to protect our rights of ways, allotments, burial grounds and other open spaces, and support the provision of public access to natural sites, such as the Blackwater River path.

9. **Flooding** – this section of the plan explains the flood risks within the parish, and prevents development in flood risk areas, or any that will increase the overall risk of flooding.

10. **Community Facilities** – this policy lists out community facilities such as community halls, places of worship, pubs and so on, and ensures that where possible these are retained in any future development proposals.

11. **Telecommunications** – with the recent increase in home-working, it is important that the community has the best possible infrastructure for broadband and mobile coverage, and this policy sets out a requirement to ensure this provision for any new development.

12. **Housing Mix** – this policy reinforces Hart's Local Plan requirement for a good mix of housing types with adequate affordable housing provision, and also states our support for Entry Level Exception sites which can deliver more affordable housing.

13. **Blackbushe Airport** – as a major local employer and a significant site within the parish, this policy supports the continuing use of the airfield as a light commercial airport as long as it does not cause a detrimental environmental impact on the community.

14. **Homeworking** – historically, planning permission has distinguished between residential locations and places of employment. This policy acknowledges that this expectation is evolving, and that certain provisions (such as broadband mentioned above) are necessary to support this change.

15. **Active Travel** – this policy encourages the use of other means of travel other than the private car through the provision of pathways, cycle-paths, crossings and connections to public transport.

In addition to these 15 policies, there is also a section headed "Community Ambitions" which covers points raised through our consultations and surveys, but which are not necessarily suitable for inclusion in a planning document. These include several items that are being taken forward by Yateley Town Council's Yateley Climate Action Network group which is looking at some of our Climate Change and Biodiversity ambitions.

Changes to Recycling site at Monteagle Hall

Earlier this year, Hart District Council decided to close the recycling bring site at the Monteagle Hall / Waitrose car park due to the immense volume of fly-tipped and dumped rubbish that they had to continually remove from the facility. Yateley Town Council reviewed the options and agreed to bring the site under our control, so we can continue to offer a place for residents to recycle items in the charity collection points. Glass and electricals recycling, however, will be removed. Residents are able to recycle glass at the kerbside and can collect extra crates from the Town Council offices (please call ahead to check our supplies). Electricals can also be recycled at standalone points at the Frogmore Leisure Centre car park and Hawley Memorial Hall. A polite reminder: if the charity collection points are full, please take your items and bags back home with you, as the charities cannot collect items unless they are inside the collection bin. Items left on the ground cost taxpayer money to arrange a special collection of these, which could be better spent on other worthwhile projects for our lovely town.
